assigned by the Department of Revenue and a copy of current commercial or occupational business license, if such a license is required by the local government entity in which the manufacturer or dealer operates a vessel.

DOCUMENTED VESSELCopy of Certificate of Documentation papers or proof that the documents are on

file with the U.S. Coast Guard and sales tax, if applicable.

GOVERNMENT VESSEL Proof of ownership, i.e., manufacturers certificate of origin, court order,

certificate of title signed by previous owner transferring ownership to the

agency.

AMPHIBIOUS VESSEL Copy of the vehicle certificate of title issued by the department.

DEFINITION OF RESIDENT AND ALIEN:

A "Resident" is any citizen of the United States who has established residence in this state and has continuously resided in this state for one year and in one county for the six months immediately preceding the initiation of a vessel titling or registration action.

An "Alien" is a person who is not a citizen of the United States, although such a person may reside in Florida.

SIGNATURE REQUIREMENT FOR CO-OWNERS AND FIRMS

All persons claiming an interest in the vessel being registered are required to sign the application for registration.

ELECTION CAMPAIGN FINANCING TRUST FUND

Florida law allows for a voluntary contribution of \$5 per taxpayer for the purpose of providing for public financing of political campaigns for the offices of Governor and member of the Cabinet.
