INFORMATION PACKET

FEDERALLY DOCUMENTED VESSELS

This packet has been designed by the Seminole County Tax Collector to help expedite the process of applying for a federally documented vessel registration.

Required Documents to apply for a Federally Documented Vessel Registration:

- 1. A completed HSMV 87244, Application to Register Non-Titled Vessel.
- 2. A copy of the executed Vessel Bill of Sale to document the amount of sales tax due, proof of payment of sales tax, or proof of tax exemption.
- 3. A copy of the current Certificate of Documentation issued by the U.S. Coast Guard or receipt that documentation has been applied for.
- 4. Six percent sales tax will be collected on the purchase price. When the vessel is registered to a Seminole County address the first \$5,000.00 of the sale price is subject to an additional 1% discretionary sales surtax.
- 5. Registration fees are determined by the length of the vessel.

Applicants exempt from titling, pursuant to Section 328.01, F.S., should complete the reverse side of this form and provide the following applicable documentation and pay the appropriate taxes and fees.

OUT OF STATE REGISTRATION	Applicant must provide a copy of the out-of-state registration which is in full force and effect.
DEALER REGISTRATION	Applicant must provide a copy of current sales tax certificate of registration assigned by the Department of Revenue and a copy of current commercial or occupational business license, if such a license is required by the local government entity in which the manufacturer or dealer operates a vessel.
DOCUMENTED VESSEL	Copy of Certificate of Documentation papers or proof that the documents are on file with the U.S. Coast Guard and sales tax, if applicable.
GOVERNMENT VESSEL	Proof of ownership, i.e., manufacturers certificate of origin, court order, certificate of title signed by previous owner transferring ownership to the agency.
AMPHIBIOUS VESSEL	Copy of the vehicle certificate of title issued by the department.

DEFINITION OF RESIDENT AND ALIEN:

A "Resident" is any citizen of the United States who has established residence in this state and has continuously resided in this state for one year and in one county for the six months immediately preceding the initiation of a vessel titling or registration action.

An "Alien" is a person who is not a citizen of the United States, although such a person may reside in Florida.

SIGNATURE REQUIREMENT FOR CO-OWNERS AND FIRMS

All persons claiming an interest in the vessel being registered are required to sign the application for registration.

ELECTION CAMPAIGN FINANCING TRUST FUND

Florida law allows for a voluntary contribution of \$5 per taxpayer for the purpose of providing for public financing of political campaigns for the offices of Governor and member of the Cabinet.
