OUT-OF-STATE TITLE FOR VESSELS

This packet has been designed by the Seminole County Tax Collector to help expedite the process of applying for a Florida title using an out-of-state title.

Required Documents to apply for a Florida Title:

1. The original out-of-state title and/or out-of-state registration. Some states do not require titles to be issued to vessels. See attached list of title states to determine if the state the vessel is coming from requires titles. If the vessel was recently purchased, the out-of-state title should be completed and signed by the seller to the purchaser. If joined by “and”, both sellers must sign to sell the vessel.
2. A completed HSMV 82040, Application for Certificate of Title with/without Registration.
3. A Vessel Bill of Sale is suggested a may be required.
4. A certified pencil tracing of the Hull Identification Number (HIN) is required if the vessel is custom built, the HIN is improperly formatted, or if any discrepancies are found in the vessel description.
5. Six percent sales tax will be collected on the purchase price. When the vessel is registered to a Seminole County address the first \$5,000.00 of the sale price is subject to an additional 1% discretionary sales surtax. Sales tax will not be collected if the vessel has been titled in the applicant’s name for six months or longer. If owned less than six months, proof of sales tax collected is necessary. If none was collected or less than 6%, additional sales tax may be due.
6. Registration fees are determined by the length of the vessel.
7. **NOTE:** Trailers are registered separately. The out-of-state certificate of title and/or a copy of the out-of-state registration are needed. If the trailer title/registration does not include an empty weight, a certified weight slip is necessary. If the trailer was just purchased a Bill of Sale with the selling price, the purchaser, and a complete description of the trailer will be required. The fees are determined by the registered owner’s date of birth, empty weight, and the license plate type.

Registering And Titling A Vessel In Florida For The First Time

A vessel that is registered with another state may be used in Florida for no more than 90 days.

An out-of-state vessel owner who does not plan to become a permanent Florida resident but plans to operate a currently registered vessel in Florida waters for more than 90 days must obtain a temporary registration from the Tax Collector's office.

Not all states require a vessel to be titled, however, Florida does require a title. See the table below for a list of states which require vessel titles, which may be used to transfer to a Florida title and registration.

To permanently register a vessel in Florida, you must present the following information:

- Current registration for the state where the vessel is registered.
- Title Document for the state where the vessel is titled (if a title state - See Table above).
- Proof of Sales Tax will be credited if vessel was purchased less than 6 months prior to registration.
- We highly recommend that you visit the Florida Vessel Title & Registration website for complete and up-to-date information.
