**Class E License and Identification Card  
Address Requirements**

All applicants obtaining an original class E license or identification card OR changing address on their credential will be required to submit **TWO** proofs of residential address **in their name**.

Applicants that cannot provide the above will need to complete the HSMV 71120 – Certification of Address form with the person certifying in a Tax Collector’s office or in front of a notary **AND** submit **TWO** proofs of address in the certifier’s name. The first document must establish if they own or lease the property and be one of the following:

- Deed • Mortgage Agreement
- Recent Monthly Mortgage Statement • Rental or Lease Agreement

Below is a list of documents that may be provided for applicants in their name or as the second document for certifiers.

Acceptable Proof of Residential Address
<ul style="list-style-type: none"> <li>• Household information document – deed, mortgage, monthly mortgage statement, or residential rental/lease agreement (agreement must include signature page)</li> <li>• Florida voter registration card</li> <li>• Valid Florida vehicle/vessel registration or title</li> <li>• Utility bills (ex. water, gas, electricity, cell phone, cable) (must be dated within the last 30 days)</li> <li>• Automobile payment booklet (must be dated within the last 30 days)</li> <li>• Selective Service card (must be dated within the last 30 days)</li> <li>• Medical or health card and/or medical bill (must be dated within the last 30 days)</li> <li>• Homeowner’s and/or automobile insurance policy or bill (must be dated within the last 30 days)</li> <li>• Employer documentation (W-2 form or 1099 form, paycheck stub)</li> <li>• A letter from a homeless shelter, transitional service provider, or half-way house verifying that the customer resides at the shelter address (must be dated within the last 30 days)</li> <li>• Financial statements (bank, credit cards, or investment accounts) (must be dated within the last 30 days)</li> <li>• Mail/documents issued by the Federal, State, County, or City government agencies (including city and county agencies (must be dated within the last 30 days)</li> </ul>

\*Envelopes are NOT considered acceptable proof of residential address

Sections 322.051 and 322.08, Florida Statutes, require that applicants provide proof of residential address documents to obtain a Florida Class E driver license or identification card. Two residential address documents from the approved documents list are required. If the applicant cannot provide two approved Florida residential address documents in their name, this affidavit must be used along with the documents provided by the individual whose name is on the proof of Florida residential address documents.
